

## **BURDEN FELLOWSHIP AND PEASE FELLOWSHIP** **GUIDELINES FOR APPLICATIONS**

### Eligibility Criteria

- 1) Must be a Ph.D. student in Biomedical Sciences graduate program
- 2) Must have completed first year graduate program core course requirements by July 1
- 3) Must be in good academic standing
- 4) Must be actively engaged in scholarly research and demonstrated aptitude to quickly grasp scientific concepts and adopt research technologies
- 5) Experience in poster or oral presentations at regional, national or international meetings or conferences, award recognitions and prior laboratory experience
- 6) Must show commitment to research in biomedical sciences (Burden fellowship) or cancer-related research (Pease Cancer fellowship)

### Additional criteria

- 1) Evidence of "distance traveled," which could include the financial necessity to maintain a heavy work schedule, being the first in family to earn a bachelor's degree, or maintaining family responsibilities to care for a disabled parent
- 2) Involvement in professional activities to enhance the diversity of the department/graduate program

Preference will be given to students who have not received the award previously.

Application Procedure: The following forms will need to be completed and submitted electronically by May 1 to the Graduate Student Services Advisor, Hermila Torres, copied to program director Dr. Byron Ford:

1. Applicant Information Form
2. Research Statement
3. Professional activities
4. Diversity Form (*optional*)
5. Two recommendation letters, including one from Major Professor (sent directly from faculty to [hermila.torres@medsch.ucr.edu](mailto:hermila.torres@medsch.ucr.edu))
6. Name your application: your last name\_program\_student last name\_award name.

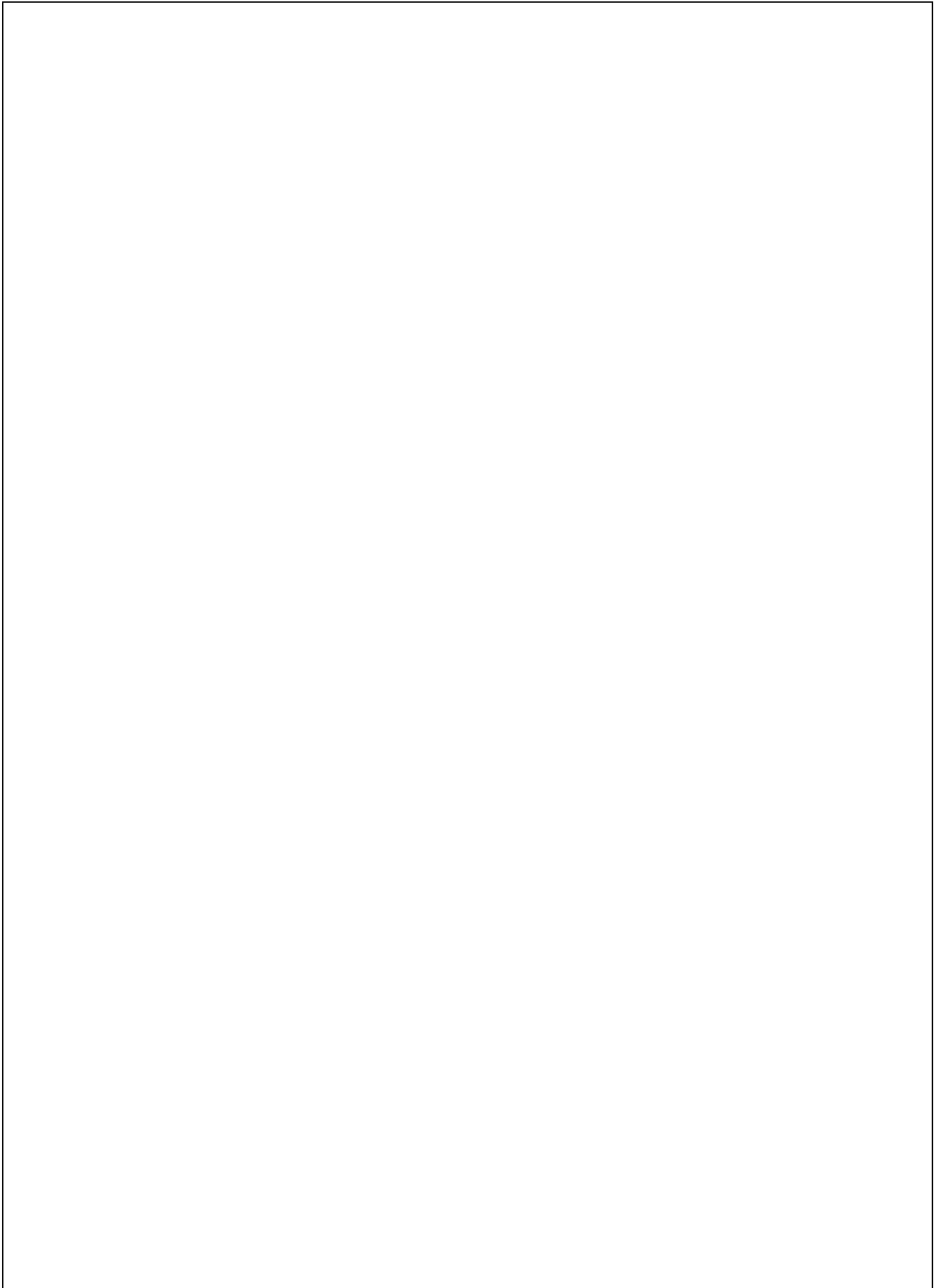

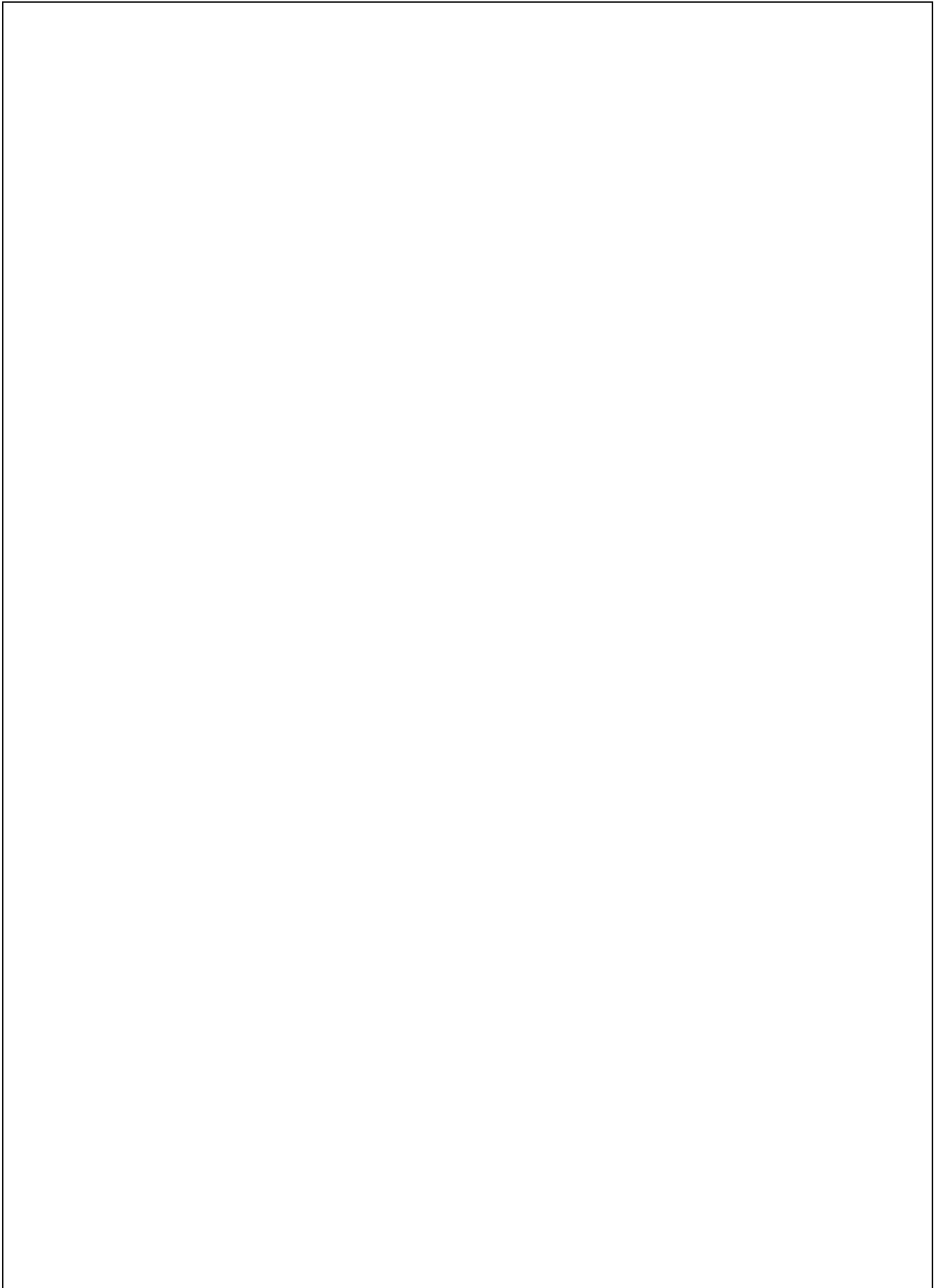
## **RESEARCH STATEMENT**

1. What is the intellectual merit of your dissertation research?
2. How would your research contribute to biomedical (Burden fellowship) or cancer (Pease fellowship) research?
3. What are your research accomplishments at UCR to date?
4. What will your professional activities entail during the coming year?
5. What are your career goals?

Each question should be followed by your response. All together, the questions with your responses are limited to 2 single spaced pages, 1 inch margins, 12 point font. You may use up to one additional page to include references cited.





## **PROFESSIONAL ACTIVITIES**

### **1. TIMELINE**

Please provide a timeline for completion of your dissertation, noting specifically when you expect to finish all research projects and when you expect to begin and complete writing the dissertation.

### **2. LIST OF PUBLICATIONS**

Please list **PUBLISHED** papers only on which you are an author. You must include the complete citation with inclusive pagination and all authors listed in the order in which they appear in the publication. You can also include manuscripts that have been submitted for publication. Do NOT include published abstracts here.

### **3. LIST OF PRESENTATIONS**

Please list all talks or posters presented at regional, national or international meetings or conferences. Indicate the name, location and date of the meeting/conference. Provide the title of your presentation, the list of authors as they appear in the conference proceedings, and indicate which author presented the work.

#### 4. EXTERNAL FUNDING

Provide a list of all proposals that **you** have written and submitted for **extramural** funding. For each proposal, indicate the agency to which it was submitted, the date of submission, whether the proposal has been funded, and, if so, the amount of funds awarded. If your dissertation mentor is the PI on any of these proposals, explain why you have included that proposal here.
